# I. The Impact of Artificial Intelligence

Knowledge is a Wonerful Gift - Nicholas Ginex

The author credits the Frontline PDS documentary that provides much of the information of six main topics amplified below.

#### 1.0 China Leads the World in AI Implementation

Artificial Intelligence automated systems and robotic controls are ushering in a new age of great potential and prosperity. But an age that will also deepen inequality, challenge democracy, and divide the world into two AI superpowers. This has been done by a young generation of people highly skilled in computer knowledge by writing software programs that can simulate human decision making in robotic machines, control movement of vehicles, replace manual productivity and mental decision making of human beings.

With the accumulation of a huge amount of data, young minds have created automated programs can use data to teach itself how to predict an outcome. This is a wonderful testament of the intellectual capability of our youth that have become successful entrepreneurs in the very challenging and technical environment of our era. But did their technical education keep pace with the attributes and human values that benefits the lives of all people to care and love one another?

Orville Schell, one of America's foremost China scholars, reported that since he first came to China in 1975 it has transformed itself from a poor, uneducated nation to a leader in the most advanced technical breakthrough in our era, the development of artificial intelligence. It began in 2017, when China's dictatorial leader, Xi Jinping announced that China would catch up with the U.S. by 2025 and lead the world by 2030. Today, China leads the world in e-commerce, drone delivery of merchandise, and their people can shop in stores where the currency

is facial recognition. In 2 and ½ years, China's AI implementation has gone from a minimal amount of wealth to the successful attainment of 18 billionaire companies.

#### 1.1 The Chinese Innovator, Kai-Fu Lee

The innovator of AI's technical growth was powered by a new generation of ambitious young techs pouring out of Chinese universities and financed by a new cadre of Chinese venture capitalists. This innovated approach, named Sinovation was created by a US educated AI scientist and businessman, Kai-Fu Lee. He was a high school graduate from Tennessee and obtained a PhD by writing an AI thesis on speech recognition at Carnegie Mellon. He was hired by Apple at 31 and developed Apple's speech-recognition technology. Kai-Fu moved on to Microsoft Research in Asia and became the head of Google China. About 10 years ago, he started his company Sinovation in Beijing.

Kai-Fu Lee has stimulated the growth of a few thousand Chinese top entrepreneurs that could take on any entrepreneur anywhere in the world. A notable entrepreneur, Cao Xudong, a 33-year CEO of the startup company Momenta, developed a driverless car technology, which has decreased the number of truck drivers in the U.S. by 50 percent and lowered the livelihood incomes of the rest. This technology is split between the U.S. and China but Kai-Fu Lee believes China will overtake the U.S. with their head start of building a new city the size of Chicago with highways that have sensors built in to facilitate automatous driving.

#### 1.2 China can Surpass U.S. AI Implementation

China has great promise to surpass the U.S. in AI innovation and implementation. A billion people use WeChat, which is the equivalent of Facebook, Messenger, PayPal and much more all on one superapplication. China can surpass the U.S. with their vast amount of data available, as they have three to four times more users than the U.S. They have 50 more times mobile payments than the U.S. and ten times more food deliveries. AI is basically run and fueled by data, which is why


China is likely to surpass the U.S. in predicting human behavior in their choices for food, cars, merchandise and processing transactions, such as loans and predicting the stock market.

China has surpassed the rest of the world in facial recognition and interpret human behavior to identify individuals by their walk. A real problem surfaces whereby the privacy of an individual and freedom of movement is eliminated as China has installed cameras to capture and process personal data that allows a powerful dictator to know the movements of any person and stop any uprising before it can materialize and crush it.

Orville perceives the ability of control of masses of people by government or dictatorial leaders using AI. He sees AI as "an experiment of extraordinary importance of whether AI can be combined in such a way that's coherent and durable in the world." He raises a serious concern. Can China meet the challenge to preserve the privacy and freedoms of its people in a one-party state with AI that is both economically and technologically innovative?

#### 1.1 The Promise of AI Has Serious Implications

A research scientist at MIT, Andrew McAfee coauthored *The Second Machine Age*. He presented a graph depicted with Figure 1 that shows human development and economic growth from 2000 BCE, where the state of human civilization was not very advanced for thousands of years in both the West and East civilizations. Growth was relatively low until the early 1900s with the steam engine, then electricity that led to the technological development of the radio and computers. By the late 1950s increasing automation initiates a rising growth in the social development and net worth of both Western and Eastern cultures that begins to go vertically upward after 2000 CE.

Andrew pointed out that it was the Industrial Revolution that led to innovation into the electrical spheres of computers, transcommunication, and artificial intelligence, which transformed much of manual labor and increased productivity with brain power. He noted that AI is a tool that allows us to overcome the limitations of our minds. This is profoundly good news. It verifies that we are entering a new era where the implementation of AI will reshape many aspects of our lives and economy as companies, governments and nonprofit organizations integrate automation into their operations. In many cases the results will benefit the lives of people such as early detection of breast and prostate cancers.

However, there are undesirous implications that automation can affect the livelihoods of many people being replaced by automated systems. This has already affected the truck driving industry where thousands of drivers have been laid off and their incomes slashed from over \$100,000 to \$40,000 dollars a year.

The loss of jobs portends not only the loss of jobs in many sectors but also, there is the threat that people will lose the freedoms of privacy, movement, and independent thinking. Will the technical benefits of automation also tear away the constitutional rights of every individual?

This question reflects a need for our great moral, intellectual, and successful business leaders to think about the future and acknowledge that our educational and moral institutions need to instill values into the shaping of our youth that will become the business leaders of tomorrow. It is our youth and business leaders that need to recognize that as they implement AI into the operations and systems of many companies that there must be a way to redirect employees who are replaced by automated processes to attain the training and given psychological help to find other paths to earn a living.

The responsibility of instilling values, moral character and integrity in our youth lies not with parents alone but it is our religious and educational institutions, at every level, that they must instill moral development, integrity and love for others. The objective is to sensitize their compassion so that they are not overcome by success of attaining wealth and try to equalize happiness and opportunities for all of humanity.

#### 1.2 The Future of Work

Nick Thompson, the editor-in-chief of the magazine Wired started out with optimism of technological change ushered in by AI. However, after a few years, he has recognized the issues AI has created and has become an observer of technological change rather than a champion of technological change. He is concerned that AI will disrupt the labor force in a country and cause a social impact that will dehumanize the high regard for life as many lives are destroyed and left behind because they may not have the intellect that can absorb and work in an AI environment.

Not all people are gifted with the desire to learn complex mental skills. It is only exceptionally educated people with fine analytical skills that will be successful in an AI world. What happens to 90% of the labor force that come from poor families, receive poor education, and not young enough to transition into an environment that requires the discipline and disposition to learn higher mathematics and computer solving techniques? This is a serious problem that needs to be solved by the AI leaders who have created the problem.


Kai-Fu Lee has publicly admitted that the public work force will be somewhat or extremely threatened by AI whereby 50 % will be affected in the next 15 years or so. He wants to warn society of what he sees as inevitable. He indicated that AI will displace more white-collar jobs than blue-collar jobs because computer programs can process quantitative analytical data, such as reporters, traders, telemarketing, tele sales, customer service and analysts.

Kai-Fu Lee has indicated that three great technological developments in the past were of a revolutionary magnitude that increased productivity and the advancement of civilization – the steam engine, electricity, and the computer. Many of the other innovations were relativity small in comparison. Kai-Fu feels the reason AI is replacing many jobs is that it can fundamentally replace our cognitive process in doing a job in its entirety and do it dramatically better.


#### 1.3 Defining the Problem

We see with Figure 2 that the advancement of civilization in terms of productivity has risen dramatically over the past 100 years. However, in Figure 3 we see that the medium income of workers has steadily fallen as the age of computer processing and automation increasingly becomes a strong part of the working environment. The figures show that while productivity increased, workers are laid off or work for less pay. The automation of labor has affected all manufacturing and administrative processes on both a manual and mental level.

Many jobs have been lost that required manual and/or mental skills and education, even workers that obtained professional training and education in colleges and universities, have been affected.

True, there are ample opportunities for young minds to pursue and be successful working in the AI environment, but even they, in 20 to 30 years, a generation, will find that the software programs become so advanced that even their mental skills of logic and technical training can be replaced with a lower percentage of AI programmers and innovators.

The question becomes, what happens to the many people who do not possess analytical skills or have not benefitted from or desire a higher education that requires a mathematical and logical mind for AI success? It is true that robots can increase productivity and cause a transition of jobs that enhance the automated process. However, it is to be acknowledged that the transition will cause the loss of many more jobs than it creates. Significantly, of greater concern, what will happen when robots cannot replace, but decrease the ability for people worldwide to use their own minds to make logical decisions? Will humans become lazy in the use of their creative gifts and will they become subject to the mass indoctrination of fake news used by unscrupulous and powerful multibillionaires that are presently using their wealth to control people in many economies?

An economist Mike Hicks, and a sociologist Emily Wornell has documented employment trends in Middle America and determined that automation has been a silent job killer. They found that the loss of jobs due to off-loading them to other countries like China, India, Mexico, Vietnam and Japan account for only 20% of jobs lost. In the last 15 to 20 years, the standard of living in America has dropped by 10 to 15 percent, which he believes is unusual for a developed country.

AI has cut jobs as robots can pack anything from soap power, cantaloupes, canned foods and articles for on-line consumers. Automated machines can pick groceries, read reports, learn routines required in stores, factories, and offices that are task oriented or process information like a cashier, fast-food worker, payroll, finance, HR, insurance companies, law firms, trading floors on Wall street, and analyst positions. Another question surfaces, will many of these workers have low incomes where they are unable to pay for a college or trade school to transition to another job or profession?

With the dire questions presented, what are the solutions to maintain the mass numbers of people that have or will lose their income earning ability? Inequality in America is becoming a looming reality.

Figure 3 shows how inequality has become significant. It used to be the net worth of the top 1 percent owned a relatively small portion of the country's wealth. Beginning with 1980, the net worth of average workers had the largest share.

By 1995 we see that the top 1% has not only exceeded the average income of Middle America wage earners they have more than doubled their net worth. It may be concluded that automation is the substitution for capital for labor and has largely contributed to the wealth of billionaires. This poses a very serious question of how to address Middle America decrease in earnings as wealthy entrepreneurs continue to increase their wealth with AI implementation at the expense of thousands of jobs lost, which creates a low standard of living experienced by workers in practically every field of mental and manual labor.

How we distribute the economic benefits attained with AI automation is going to need moral and ethical considerations. Kai-Fu Lee has succinctly reasoned that the growing use of AI poses a moral consideration for society over the next several decades as workers continue to be replaced by automation.

#### 1.4 The Surveillance Capitalists

Professor emerita, Shoshana Zuboff, a Harvard Business School graduate, is presently working on a book that identifies the new age where AI affects the economic aspects of society and calls it, Surveillance Capitalism. She says, what surveillance capitalism claims is private, human experience. It is characterized as a free source of raw material, fabricated into predictions of human behavior. Businesses are wanting to know what we do now, soon, or later to maximize sales and profits.

Google started in 1998 by two young Stanford grad students who developed a powerful search engine. To maximize income, they began to accept ads from businesses seeking to reach the millions of potential buyers over the Internet to make more money. They realized that the clicks by users can be utilized as data to identify certain wants and they designed algorisms to predict and identify user's interests. Capitalizing on interpreting such data Google was able to increase their profits as

businesses sought them to direct users to their products with ads they were willing to pay for. Between the years of 2000 and 2004, Google's revenue increased by 3,590 percent.

In the same way, Facebook was able to extrapolate personal data and increase their profit margins with ads placed by countless businesses. Computer data about users were extended to extracting data from many public institutions such as health organizations where women's menstrual cycles are recorded. There are serious dilemmas that can affect the balance of society's freedoms. What if large corporations like Google and Facebook use the data for other than personal user wants? What if a powerful dictator or government agencies are able to use AI to gain access to knowing the behavior of its citizens whereby, they can anticipate an insurrection or mob protests. Can society be controlled by not only anticipating behavior but modifying behavior through fake news? They can affect the reactions of people by what is termed "social contagion" with online messaging. In an unsuspecting manner, using fake news, they can affect the way one votes and make people feel happy or sad by influencing the tenor and content of the news or ads. In short, usage of AI utilization of data can change real-world behavior.

But how can the idea of contagion affect whole societies and nations? Is it possible that Google and Facebook, for example, are not only interested in influencing a user's wants but may succumb to the billions of dollars of a corrupt dictator, multibillionaire, or surreptitious organization? Will a business decide to be trustworthy or will the acceptance of an easy payment of tens of millions be the determining factor? This concern is real when a Cambridge Analytical scandal was investigated. It was learned that Facebook president Mark Zuckerberg had to appear before Congress and explain in 2018 how the data of 87 million Facebook users had been harvested by a political consulting company based in the U.K. The purpose was to target and manipulate voters in the 2016 presidential election as well as the Brexit referendum. Cambridge Analytical had been largely funded by a conservative hedge fund billionaire Robert Mercer. Shoshana Zuboff, is a writer who has dedicated the last twelve years to observing and analyzing the quiet

emergence of a fundamentally anti-democratic new economic logic that she calls surveillance capitalism. She claims that the digital future has been hijacked by this rogue capitalism that now owns and operates the internet. She has aptly surfaced the fact that any billionaire with enough money can buy the data, buy the AI machine intelligence capabilities, buy the skilled data scientists and thereby infect, infiltrate and upend our democracy.

Alastair Mactaggart, a California real estate developer, had no idea about this new "surveillance business" until in 2015 he had a conversation with an engineer. He learned that big automated search companies can learn a lot about a person's preferences and possible decisions. Big business can extrapolate data to learn about your thoughts, your dreams, who your friends are, what you're thinking, and what your private thoughts are. Surveillance data is further obtained with such in-home devices, such as an Alexa or Google voice recognition system that can be placed in living rooms, bedrooms and kitchens.

The impact of Cambridge Analytical automation may be considered old school using tools that was 10 years old compared with the AI tool developed today. Today, what we're looking at now, with current tools and machine learning is that the ability to manipulate elections and opinions. But more broadly, is the indiscriminate use of personal data by unscrupulous dictators, multibillionaires, and surreptitious government agencies.

Concerns are also raised by AI pioneer, Yoshua Bengio. If the interests of leaders go against the values of democracy using the AI tools then democracy of the people is in danger. He believes that when scientists can or will have an impact on society, they have a responsibility. Just as physicists of the 2<sup>nd</sup> world wars warned government leaders of the destructive dangers of nuclear power to human life and our earth so must that same responsibility surface to control the operation and expansion of all businesses using machine learning and AI.

A concerned citizen, Alastair Mactaggart was alarmed how AI software can affect the voting outcome of a presidential election. Paid to increase

the voter turnout in some states and their votes for a candidate, AI companies can affect the election outcome with messages purposefully designed on the Internet to influence a particular choice. He claims that with the data obtained by AI companies, they know just about everybody intimately. They know who's a racist, who's a homophobe, who's a misogynist, who's a conspiracy theorist, and know the lazy and gullible people.

The AI programmers have an indirect way of communication with the Internet viewer. This is power and Mactaggart sought to pass a law to give consumers control of their digital data and spent over 4 million dollars of his own money in an effort to rein in the insidious power concentrated in Silicon Valley. An area where large AI companies are located, which are Google, Facebook, AT&T and Comcast. A monumental effort, Mactaggart faced a combined AI adversary that opposed his initiative and overwhelmed his 4 million with over \$6 trillion dollars. With unanimous approval, his bill was passed by the California State House. This bill gave the right for a Californian to request from any company to reveal what personal information they have collected in the last 12 months and the right to say no to any company from collecting privacy information and sell it.

In spite of the California Internet privacy law, AI has already spread so far into our lives and work. It's in healthcare, in education, in criminal justice, in the experience of shoppers, and has pervaded so many elements of everyday life. Data is captured with use of phone calls, 5G cameras, being filmed at job interviews, and is completely opaque to people. The question arises, how do we make this surreptitious data transparent and more accountable?

#### 1.5 The Surveillance State

In an authoritarian state like China, social stability is controlled by the government and AI can oversee social behavior by utilizing 600 million 5G cameras that will be deployed by 2020 end to scan the country for unrest. The government is watching to the extent that they have the technology of 'sharp eyes', which are cameras on every major street and corner of every village in China, which means everywhere. They can use real-time data to pick up a face or action and with TV cameras that can identify individuals by their face or by the way they walk.

China is achieving or has achieved total surveillance of the state whereby every aspect of human activity is monitored everywhere. Even conversations and phone calls are recorded and monitored to determine if some people need to be indoctrinated or re-educated politically in designated camps where torture and deaths have occurred. Loss of privacy with recognition data has become so prevalent that bar codes are placed on the doors of homes where people live to reveal what kind of people they are.

China has used AI to identify, punish, and eliminate a religious group, such as a Muslim community. China is also promoting and selling its AI technology to other countries, such as Pakistan, Venezuela, Sudan, Ecuador, Bolivia, Cambodia, Argentina, Africa and even Iran. These countries are acquiring AI technology to squelch political resentment or political upheaval. China's influence is spreading all over the world, especially in countries where monarchy and dictatorships exists by providing loans for infrastructure development and controlling people with surveillance systems to maintain social stability.

Sales of AI equipment and expertise is going on all over the world, where as many as 58 countries are implementing AI technology making China one of the richest nations. China is thereby becoming interconnected with these countries as shared resources, shared telecommunications systems, shared infrastructure, shared digital systems, and shared mobile phone technologies that is growing around the world at the exclusion of the West. The interconnection of data from all these countries enables China to be a dominate threat to America.

At the present time, the world has been split in two where there will be a Chinese tech center and an American tech center. And countries will get to choose which one they want to align themselves with. The U.S. fears that as countries around the world are supplied with 5G by China,

the Chinese government could have backdoor access to their equipment. To lessen the fear, Huawei, the Chinese company that manufactures and sells 5G equipment around the world conceded to provide transparency of its AI software. However, the head of Huawei, Ren Zhengfei, can say, that his company is privately owned and they don't take orders from the Communist Party, but when ordered, everybody knows they will respond to the will of the Chinese government.

What has become apparent, is that AI has become the tool of choice for an authoritarian government, whereby the hope for the social integration of moral and ethical values worldwide cannot be realized. It has become a reality that China and America are diverging instead of integrating morality and ethical values; this becomes a great challenge and concern for all people to balance the tool of AI for the future of mankind rather than its possible conflict and destruction.

In the future, we can expect AI will replace or reform transportation but also, healthcare, education, and many jobs that can be computerized and performed by automation and robots.

With the rise of the two super powers, China and America, Kai-Fu Lee believes the super powers need to work together as a force for good. He believes if we do a good job, in the next 20 years AI could bring on an age of enlightenment for our children in the future. It eliminates routine jobs and pushes us to do what we love and pushes us to think what it means to be human. A question he surfaces is how can AI be used for a government to safeguard its citizens but not encroach on an individual's rights and privacies? He points out that a government may exceed the limits of control. But he was not specific to paint a vivid picture that controls can be severe enough to have individuals monitored like prisoners and people abused where the values of morality, integrity and the freedom to make individual choices are compromised.

Can AI be transitioned to improve our social norms and increase the collective wisdom around the world? This is a good question. For AI to be successful in making our world better in the future, the values of morality, justice, truthfulness, and compassion for each other


must be instilled in not only the developers of this powerful tool, but also the leaders in government, businesses, education and religious organizations, including publishers and writers of books; especially the wealthy multibillionaires that own or fund TV, Internet and news media. The values are what builds integrity in all people and must be instilled in their work ethic. Can all these leaders highly regard integrity? This is the ultimate goal for the next stage of human development. Integrity is instilled with a basic desire inherent in each of us, the ability to love one another.

# II. Understanding the AI Impact

**Knowledge and love leads to wisdom** – Nicholas Ginex

In Chapter I, the reader was introduced to the unlimited capabilities of AI as a tool to eliminate routine manual actions and repetitive mental processes prevalent in both blue and white-collar jobs. Chaper I presented Figures 1, 2 and 3, which illustrated that since 2000 BCE to the middle 1900s CE, the economic growth of civilizations had been relatively stable but low. It was not until the new technology of AI became a new tool for production of many companies that the incomes of business leaders diverged from the medium incomes of average workers. By 1995 the top 1% of wage earners in the United States passed the net worth of average workers and created an enormous gap in 2015. Net worth is your total value if you sold everything and paid off all of your debts.

This gap between the net worth of the average worker and the net worth of 1% of billionaires in America was largely caused by the implementation of AI that replaced workers with the use of automated systems and robots. A gap so disparately large that it gives one a feeling of economic repression experienced by the average worker. Figure 4, originated by Forbes, presents a view of that gap starting with the year 2000. It shows the net worth of the world's billionaires increased from less than \$1 trillion in 2000 to over \$7 trillion in 2015. An increase of 6 trillion in 15 years is incomprehensible when looking back at the low net worth of the U.S. economy since the Industrial Revolution.



#### 4. Billionaires' Net Worth Worth in Trillions of Dollars

It behooves the reader to learn who are the 1% billionaires that have incomes that far exceed that of the average worker. Do they have any intention to resolve the incongruent difference in wages that is causing a severe change in the quality of life in America as incomes decrease, jobs are lost, and millions of people are finding their futures looking dim to attain an education and better life for themselves and their children?

#### 2.0 Wealth of the Top 10 Billionaires in America

According to the 2019 annual Forbes list of the world's billionaires there were 607 billionaires in the U.S. and about 2,500 billionaires worldwide from 66 countries, with a combined net worth of \$8.6 trillion. The annual Forbes list of the world's billionaires, dated March 18, 2020, identified the top 10 wealthiest billionaires. Figure 5 should satisfy the interest of readers to know who they are. Figure 6 provides a comparison of the billionaires in the years of 2017 and 2020 to see which

ones maintained their position as being in the world's top five. We find that Mark Zuckerberg dropped to 7<sup>th</sup> place in 2020 and three U.S. billionaires that remained at the top 5 were Bill Gates, Warren Buffett and Jeff Bezos. It is to be noted two interesting facts about the ownership of wealth:

- According to a 2017 Oxfam report, just 8 billionaires own half the wealth in the world.
- In 2017, 500 of the wealthiest people in the world became \$1 trillion dollars richer, reported by The Washington Post, 27 Dec 2017.

With all of the accumulated wealth by the top 8 billionaires in America have any of them given of their time and money to try to ameliorate the devastating effect of AI on the economy of the United States?

This is an important question. An analysis will reveal if highly successful people, the billionaires of America, acknowledge there are millions of people who can benefit from their help by improving their quality of life.

It will be worthwhile to learn if highly successful people have the compassion, love and integrity to share their wealth with people that are poor and average workers who have little hope for a better life.

An article by Taylor Nicole Rogers, posted on the Internet November 27, 2019, indicated two facts worth noting about the top ten richest billionaires in the world.

- America's 10 wealthiest people gave 0.94% of their net worth to charity in 2018.
- Three of America's richest billionaires gave 0.0% of their net worth to charity in 2018.

To give the reader some idea of billionaire contributions. Only those billionaires that funded charitable organizations in 2018 and made the top 10 list in 2020 are identified below. The 2018 net worth and donated figures were obtained from the Rogers article.

Jeff Bezos, Founder and CEO of Amazon. With 160 billion net worth, he donated 131 million (0.1%) to charity. On November 21, 2020, his

nonprofit Day One Fund donated \$98.5 million to multiple charities fighting homelessness.

Bill Gates, Microsoft founder and full-time philanthropist. With 97 billion net worth, he donated 2.5 billion (2.6%) to charity. The Gates family along with Warren Buffett launched the Giving Pledge Movement in 2010, which states a commitment to give the majority of their wealth to philanthropy or charitable causes, either during their lifetimes or in their wills.

Warren Buffett, Berkshire Hathaway CEO. With 88.3 billion net worth, he donated 3.4 billion (3.9%) to charity. He gave to several charities, including the Bill and Melinda Gates Foundation.

Mark Zuckerberg, Founded Facebook. With 61 billion net worth, he donated 410 million (0.7%) to charity. He and his wife, Priscilla Chan, have donated more than \$1 billion toward education and medical research, including a multimillion-dollar donation to a San Francisco hospital named Zuckerberg after him. They pledged to give away 99% of their Facebook shares to charity during their lifetimes.

Larry Ellison, Oracle Founder. With 58.4 billion net worth, he donated 25 million (0.0%) to charity. It is reported that he gave 100 and 200 million to help eliminate Polio and Cancer, respectively.

Larry Page (On 2018 but not on 2020 top 10 list). He is CEO of Google's parent company Alphabet.

With 53.8 billion net worth, he donated 25 million (0.0%) to charity. Page pledged \$25 million in 2014 to fight Ebola.

#### 2.1 Results of the Wealthy Donations

The above sample of the 6 top billionaires of 2018 serve to give some idea of how some of the wealthiest have donated to help people who are poor and disadvantaged to attain a better life. It shows that with their combined wealth of \$407.39 billion and an average donation of \$7,864

million, the percentage given to charity was negligible at 0.00001.93%. It is not only ludicrous but a sad testament that our wealthiest billionaires realistically gave zero of their combined wealth in an effort to assist millions of people in need.

The results of top net worth billionaires give a dim view of the future for half the people around the world who, by no fault of their own, have been born into poverty or lacked an education to live a decent life. This presents a shameful realization that successful billionaires have contributed very little to care for the poor and low-income workers in America. The numbers also reveal that those with exorbitant incomes could do much more to improve the quality of life for all Americans.

#### 2.2 How Two Billionaires Use Their Net Worth

The question that surfaces is are billionaires helping to use their wealth to advance the prosperity of America? This question is significant because there are some billionaires that are investing their wealth into areas that are detrimental to America's economy, its democracy, and viability that offers personal freedoms to all its citizens than any other nation in the world.

Only two billionaires are reviewed below, George Soros and Bill Gates. A very small sample, but their actions are indicative of what wealthy billionaires can do with the power they have to influence news media and push for their agenda of disruption, misinformation and control of America. Let's see why this assertion is valid.

George Soros: On June 4, 2020, Humans Are Free posted an article titled, "The Proof that George Soros and His Open Society Foundations Have Been Funneling Money to the George Floyd Rioters." The article verifies that George Soros has given billions to fund the looting, destruction of property, riots, and killings in cities across America. This havoc to destroy America ultimately depletes the economy and instills fear, increased bigotry between the races, and serves to promote an agenda of a new world order. To manipulate his use of power he has

funded the Media Matters organization and numerous media outlets such as the New York Times, Los Angeles Times and the National Public Radio. These media outlets serve to distort the truth about his ignominious actions and ferments anger and bigotry between the white, black and ethnic communities.

His funds are issued to extremist groups to subsidize street violence and disrupt law and order in many cities. As of February 2018, he had a net worth of \$8 billion, having donated more than \$32 billion to his philanthropic agency, the Open Society Foundations. Through this society he supports liberal left-wing and anti-American activism in the U.S. and work against President Trump's agenda. One such liberal group, funded by Soros' Open Society Foundation is MoveOn.Org. This group was responsible for many of the riots and protests at Donald Trump's campaign rallies, some of which became violent and dangerous.

An article in LifeSiteNews on June 17, 2020 by Gualberto Garcia Jones titled, "Are riots rattling US cities part of Soros' plan to re-shape America and take down Trump?" It revealed that Soros and other leftists have been plotting against Trump since 2016. Gualberto provided a Politico Magazine report that indicated just six days after President Trump won the 2016 election, the Democracy Alliance, a George Soros funded dark money organization made up of 110 billionaires, met at the Mandarin Oriental Hotel in Washington, D.C. to formally organize the Resistance. Four days of closed-door meetings, the Resistance army was formed. In total there were 172 organizations, many of them already active during other leftist uprisings such as Occupy Wall Street, the anti-capitalist riots at international financial meetings, the climate protests, the anti-war and of course, the Black Lives Matter and ANTIFA protests.

The Soros radical left objective is to destabilize America and return to his goal of a one-world government of the elites, by the elites and for the elites. There are power-hungry billionaires who want to maintain a global status quo, which is threatened by the independent thinking of President Trump who loves America.

Bill Gates: This 97 billion net worth billionaire keeps company with a select group of billionaires that have visions of a one-world economy and control of the world's population with their control of the fake news media. Gates is so extensively involved in financing artificial intelligence companies and the many companies that use AI automated data processing and identification systems that it was necessary for this author to reveal what types of activities he has funded. Though lengthy, it will reveal his desire to gain more power and wealth rather than share his billions to take the homeless off the streets in American cities, assist those who have lost their jobs due to AI automated systems, and contribute to disadvantaged youths and workers funds to attain an education or retraining to lead respectable lives.

Bill and Melinda Gates are the 2<sup>nd</sup> highest funders of the World Health Organization and together they sponsor a one world agenda. The coronavirus lockdown of America and interest in vaccines for the whole world is part of this agenda. Bill Gates is funding two patents that reveal control of human beings.

One patent is with Microsoft Technology, an LLC which develops a cryptocurrency system that uses body activity data to solve difficult problems or control mental processes. The other patent is by AT&T to develop ways for biological hosts to perform and control interfaces between interhost networks and interhost networks within biological hosts. The idea is to perform biological translations to communicate to and from biological hosts, namely humans. In simple terms, automated AI networks are used that can control human beings and communication between human beings.

The above efforts are part of the Artificial Intelligence realm of innovation. Wealthy capitalists like Bill Gates are welcoming the age of surveillance capitalism where they are able to utilize data obtained from the minds and behavioral actions of millions of human beings. With such data, by accessing and controlling human behavior, they can control financial markets and increase their wealth and world dominance.

Bill Gates has strongly supported population control by financing 20 million dollars to Microchips Biotech to develop a wireless implant that can be inserted on/under the skin of a female to render her infertile for as much as 16 years and which can be turned on and off with remote control. However, Gates endeavors in population control is not just control of population increase but ultimately, control and manipulation of the population. In 2017, Gates founded and funded a Gavi alliance with the Gates Foundation, the World Health Organization, and the World Bank with vaccine manufacturers to create and control a world market for vaccines.

Deviating from his core mission of vaccinating every child on the planet, Gates funded companies developing ways of implanting every child with a digital biometric identity to store the child's medical history. Further research was made to implant a child with a multiple dissolvable needle patch that has a microneedle array of vaccines, which can be independently activated and retain a record of their vaccine history. Gates vision ties together the vaccination drive into the biometric identity drive, which ties into the cashless society drive. This vision requires everyone to receive government mandated vaccinations, whereby everyone will have their biometric details recorded in nationally-administered, globally-integrated digital databases. This system not only removes privacy from our lives, it can also be abused. Companies have been found to buy the ID data of a person (name, address, postal code, photo, phone number, email, computer clicks of personal likes and dislikes) and use it to attract buyers of their products.

On May 17, 2020, a Stillness in the Storm article titled, "Bill Gates and the Population Control Grid" revealed that Gates has not only supported global health organizations that can coordinate worldwide vaccination but use a government mandated program to achieve control over the global population itself.

Another Stillness in the Storm author, Mac Slavo reported on June 10, 2020, that Bill Gates would benefit from a government contact tracing program with a 100 million windfall. Six months before the coronavirus

pandemic, Gates and a U.S. Congressman Bobby L. Rush worked on a "tracing deal" in Rwanda, East Africa in mid-August of 2019.

An Instagram post by Robert F. Kennedy Jr. on April 9<sup>th</sup>, 2020 exposes Bill Gates devastating plan to pursue development of vaccines that threatens the health of people around the world. It states:

"#Vaccines, for #BillGates, are a strategic philanthropy that feed his many vaccine-related businesses (including #Microsoft's ambition to control a global vac ID enterprise) and give him dictatorial control over global health policy—the spear tip of corporate neo-imperialism.

Gates' obsession with vaccines seems fueled by a messianic conviction that he is ordained to save the world with technology and a god-like willingness to experiment with the lives of lesser humans."

The above activities by Bill Gates are a preview of his intentions of controlling the world's population and expanding his wealth in a world where, with the use of AI and implemented vaccinations, every person is monitored, analyzed, and databased in real-time by controlling governments. Such an agenda implemented on an international scale can satisfy an objective for a new world order where the elites maintain power and control.

### 2.3 Artificial Intelligence and the World Economic Forum

On July 6<sup>th</sup>, 2020, Mr. Spiro Skouras posted a U-Tube video titled, "Big Tech Bill Gates Conspiracy Control." He gave a disturbing glimpse into the future whereby AI is funded by multibillionaires to develop a digitalized system that controls everything and everyone in a global world order. The World Economic Forum (WEF), founded in 1971, is an International Organization for Public-Private Cooperation. It is part of the global world order supported by the United Nations, the Central Banks, the mega corporations and governments, including China and the United States; from a broad perspective, they may be considered the entire World Establishment. All of these entities are all onboard with an agenda to usher in a global system of control falsely justified

by the coronavirus pandemic, which is of course being blamed for the economic crisis, the ensuing civil unrest, and violence in many U.S. cities like Chicago, New York, Philadelphia, and Minneapolis.

Mr. Skouras presented a speech given on June 6, 2020 by Klaus Schwab, Founder and Executive Chairman of the WEF. A portion is provided here because it supports the AI solution presented in Chapter III. He champions the idea that, "No, business is not just an economic unit, it is a social organism. It has to contribute to society." As such, he promotes a strong belief that a modern enterprise must serve not only shareholders but all stakeholders1 to achieve long-term growth and prosperity. He is the originator of the concept that "stakeholders must combine their economic success with social responsibility," which is a founding principle of the WEF. He has established two other foundations to integrate young people as a strong voice for the future into global decision making processes. The purpose is to encourage their engagement in concrete projects that address social problems and to promote innovative thinking for the future. The WEF has a partnership with the World Health Organization (WHO) where Klaus Schwab delivered his speech presented below.

"The Sir Kobe-19 (Coronavirus) has shown us that our old systems are not fit anymore for the 21<sup>st</sup> century. It has laid bare the fundamental lack of social cohesion, fairness, inclusion and equality. Now is the historical moments of time not only to fight a severe virus but to shape the system for the need for the post corona era. We have a choice, to remain passive, which would lead to the amplification of many of the trends we see today. Polarization, nationalism, racism, and ultimately increased social unrest and conflicts. But we have another choice, we can build a new social contract, particularly integrating the next generation. We can change our behavior to be in harmony with nature again and we can make sure that the technologies of the force (AI) industry evolution are best utilized to provide us with better lives. In short, we need a great reset."

Stakeholders exist on four levels: 1. Governments and International Organizations,

<sup>2.</sup> Business, 3. Civil Society and 4. Young Generation.

Notice how the above speech pointed to polarization, nationalism, racism, and increased social unrest and conflicts. Could it be that China and mulibillionaires like Bill Gates have in fact supported the spread of the Coronaviris to cause a downturn of the U.S. economy? Could the polarization and racism in U.S. cities been due to George Soros providing funding support to left wing activists that create mob violence, destruction of property and unrest? The charge of racism in the U.S. can be seen to be extremely false as people all over the world are trying to come to the U.S. knowing they have an opportunity to lead a better life where Americans accept people of different nationalities, color and political beliefs.

Notice the statement, "We can change our behavior to be in harmony with nature again and we can make sure that the technologies of the force (AI) industry evolution are best utilized to provide us with better lives. In short, we need a great reset."

This statement is nebulous by saying we can change our behavior to be in harmony with nature again. What does he mean? How does this leader equate harmony with nature again with the digitalization of data being absorbed by the human brain? Yes, there are many ways that the human mind can be tutored to absorb information and acquire knowledge, but AI experts have to be careful to protect the human mind from being controlled by artificial intelligence. That is, in the development of the mental capabilities of a human being there must also be given great attention to the assimilation of values that develops integrity in a person. When the human mind only thinks like a robot that only acquiesce to the commands of an AI expert or automated process, then humanity and the precious life of a person is lost.

### Multibillionaires Are a Potential Threat to the 2.4 Freedoms and Well-Being of Americans

In Section 2.3. Mr. Spiro Skouras gave a disturbing glimpse into the future by revealing that many multibillionaires are funding, and in many cases invested in, AI projects to develop automated systems

that survey and control everyone in a global world order. Part of such control is fundamentally established with control of the news media to propagandize, indoctrinate and influence the minds of people. Over the past four years, Americans have experienced an extraordinary expanse of "fake news" used against the President of the United States. The Media Research Center analyzed all coverage of President Trump and his administration since he took office in 2017 and found that a whopping 96 percent have been negative.

Negative coverage or fake news has occurred to misinform the American people during the Russian hoax, which was perpetrated by the Democratic party with reporting that was unverified or not researched for authenticity by the news media. It is apparent that negative fake news is fed to the American public by news media companies that are owned by multibillionaires. Such actions are sanctioned at the top of these media companies by wealthy billionaires that appear to promote an agenda to precondition and program the public. A prime example of misinformation is more than seven decades of feeding the public that Extraterrestrials are a hoax and UFOs are not real. True, the news media were controlled by CIA and DIA agencies under orders by the military industrial complex (MIC), which is controlled by wealthy and powerful multibillionaires. In fact, the MIC may be considered a surreptitious and shadow government that till today, every U.S. president has had no authority or control over.

Beginning with media control by the MIC to falsify and deliberately misinform the public for decades has become a common practice as multibillionaires that own major portions of the news media are using their media enterprises to indoctrinate and misinform the public to achieve their own insidious agendas.

Presently, there are countless interference violations by the news media and powerful internet software companies, such as Facebook and Google that not only misinform the public but also censor free speech. On August 4, 2020, Facebook Inc. took down a post by President Trump for stating that children are "almost immune" to COVID-19. The statement by President Trump is a scientific fact whereby he was

trying to reduce public anxiety. However, a Facebook spokesman said he violated rules against sharing misinformation about the coronavirus and stated, "This video includes false claims that a group of people is immune from COVID-19. Which is a violation of our policies around harmful COVID misinformation."

To take down a post by the President of the United States for stating children are almost immune is an action that had to be caused by dislike for the President. For there was no harm in his statement. By allowing "freedom of speech," Facebook readers of his post would have had an opportunity to offer their views. However, when the President of the United States is censored for giving his assessment that children are almost immune to the coronavirus, it becomes clear that it is the authority at the top, namely multibillionaire ownership, that authorizes such arbitrary controls that diminishes free speech.

Corruption by the media does not only exist in presenting false or fake news to the public, but censorship is extremely powerful in affecting the outcomes of a presidential election. August 6, 2020, Zach Vorhies, a former employee of Google, was interviewed on the www.humansarefree. com YouTube web site hosted by Spiro Skouras. Zach stated that, "Google has the power to rig the election, they have been caught rigging the election already. Not just in the United States but meddling in Ireland and meddling in Brazil. You know this is a technocracy; this is the biggest threat that we face in America right now is Google. We're going to stop censorship on YouTube. The fascists of a hundred years ago burned books and the fascists of today burn bits. Every single time a video gets deleted off of YouTube, every single time a site gets deleted from the Google index that's an act of burning bits. So we're going to stop the burning of bits with our stop bit burning campaign."

While employed by Google, Zack gathered documents inside the company and found that Google was doing seditious activities against the President. Google deleted a word out of the Arabic dictionary "café" from the President's tweet in order to play into the media's attempt to use the 25<sup>th</sup> amendment (addresses the event when a president dies in office, quit, is removed by impeachment or become physically or

mentally unable to serve) to make the president look like he does not have the mental capacity to serve as president. Zack left the company believing this was a seditious and treasonous act and went on to disclose it to the public. That's how he got connected with Project Veritas that did a sting operation and the rest is history. Project Veritas encourages people to come forward with any information they have about fraudulent or corrupt behavior and their legal record stands at 7 to 0.

Google is a public traded media company and the following multibillionaires have major ownership of its stock: Larry Page, net worth of \$60 billion (8/2020), Sergey Brin, net worth of \$52.5 billion (8/2020) and Eric Schmidt, net worth of \$16 billion (8/2020). They are mentioned with no intent of maligning their integrity but to make the public aware that there are many multibillionaires that have enough wealth to be a threat to the freedoms that constitute the United States.

The prime objective of the news media has always been to diligently obtain the facts and inform the public of the truth. This objective is meaningless today by the overwhelming amount of fake news. Below is a list of billionaires who are owners of news media and TV stations. Many are immune to the agenda of a global world order, but as can be seen by the involvement of Bill Gates in AI activities, billionaires can be more powerful than the US president. Indiscriminate use of their wealth pose a threat to not only the freedoms Americans have fought for but can be an insidious threat to their health and well-being.

# Michael Bloomberg-Bloomberg Limited Partnership and Bloomberg Media: Net Worth: \$65 billion, 2/2020

Michael Bloomberg, the richest billionaire in the media business, cofounded his financial data company in 1981 and expanded into business news coverage. In 2009, Bloomberg LP bought Business Week magazine and operates one of the world's largest media organizations, with 2,700 journalists and analysts across its text, magazine and broadcast operations in 120 countries.

### Rupert Murdoch -News Corp: Net Worth: \$18 billion, 7/2020

Rupert Murdoch, former CEO of 21st Century Fox, the parent of powerhouse cable TV channel Fox News, may well be the world's most powerful media tycoon. He is executive co-chairman of 21st Century Fox with his son Lachlan and is also chairman of News Corp, which owns The Wall Street Journal and other publications. Altogether, his family controls 120 newspapers across five countries.

## Donald and Sam Newhouse -Advance Publications: Donald and Sam Net Worth is \$11.8 and \$13 billion, respectively.

Advance Publications owns newspapers in 25 cities and towns across America and is the country's largest privately-held newspaper chain. Conde Nast, a unit of Advance Publications, publishes magazines including Wired, Vanity Fair, The New Yorker and Vogue. Sam died in 1979.

### Cox Family-Atlanta Journal-Constitution: Jim Kennedy net worth: \$8.2 billion, 8/2020

The Cox Media Group Division today owns the Atlanta Journal-Constitution and six other daily newspapers, more than a dozen nondaily publications, 14 broadcast television stations, one local cable channel and 59 radio stations.

### Jeff Bezos - The Washington Post: Net Worth: \$180+ billion, 7/2020

Amazon founder Jeff Bezos bought The Washington Post for \$250 million in 2013. Since beginning his run for president, Trump has accused Bezos of using the Washington Post to get tax breaks for Amazon and sending reporters to undermine his presidency.

### Mortimer Zuckerman - US News & World Report, New York Daily News: Net Worth: \$2.5 billion, 2/2018

Real estate billionaire Mortimer Zuckerman is the owner of both US News & World Report and the New York Daily News. Zuckerman serves as chairman and editor-in-chief of U.S. News & World Report, which he bought in 1984.

### Stanley Hubbard Broadcasting: Net worth 2.1 billon, 2020

Media mogul Stanley Hubbard is CEO of Hubbard Broadcasting, which has 13 TV stations, including a number of ABC and NBC news affiliates in the Midwest, and 48 radio stations. In August, Hubbard bought a stake in PodcastOne, a one-stop shop app for podcasts, through Hubbard Broadcasting.

## Patrick Soon-Shiong - Tribune Publishing Co.: Net worth 15.5 billion, 7/2020

L.A. doctor and pharmaceutical billionaire Patrick Soon-Shiong is now the vice chairman of the Tribune Publishing company, which owns papers like The Los Angeles Times and The Chicago Tribune. In an interview with CNBC, Soon-Shiong described his investment as an "opportunity to actually transform this newspaper world into this next generation."

## Carlos Slim Helu - The New York Times: Net worth 50.3 billion, 2020

The New York Times published an article last Friday criticizing the power that billionaires wield over media companies. One ultra-wealthy media investor not mentioned in the story: Mexican billionaire Carlos Slim Helu, who owns the largest individual stake in the Times. Slim more than doubled his stake in The New York Times in June 2015 to approximately 17% of the media company.

### Warren Buffett - regional daily papers: Net worth 81 billion, 2020

Warren Buffett, as CEO of Berkshire Hathaway, has invested in a number of small newspapers and owns about 70 dailies today. In 2012, Berkshire Hathaway acquired 63 daily newspapers and weeklies in Virginia, North Carolina, South Carolina and Alabama from Media General for \$142 million.

### 2.5 **Evaluating the Net Worth of American Workers and** Multimillionaires.

After a brief review of Georg Soros and Bill Gates, the American people need to evaluate their net worth by comparing it to such billionaires. With honest reflection, how much more is a millionaire or billionaire worth over a skilled or professional worker in the U.S.?

Let's compare the annual wage of a professional or skilled worker with that of a corporate manager or millionaire to see if the numbers show how much more one person is worth over the other. According to salary. com, there are 1,421 jobs in the Skilled and Trades category. Annual salaries can vary and range from \$22,605 to \$311,215 depending on the job, industry, location, experience, skills, education, and other factors.

Regarding annual salaries of those with a Professional Degree, smartest. com indicated \$89,960 per year.

On average, it can be surmised that an annual salary of \$200,000 per year is a bit on the high side but it is a fair estimate that will be used as the basis for professional and skilled workers.


The figures below show how much more millionaires are worth over the average professional and skilled worker. It is astounding to find a millionaire's salary can be more than 5 to 5,000 greater than the average professional or skilled worker.

However, to give the reader another realistic view of the imbalance in salary, let's consider the average income of a physician to that of a millionaire. The length of education of doctors and the skills required of surgeons are to be respected. Figure 7 illustrates the average annual salaries in the medical profession is around \$350,000.

Comparing a medical annual salary of \$350,000 to a millionaire making 1,000,000 or 2,000,000 annual salary, shows that the millionaire is worth 2.8 or 5.7 times more, respectively.

Throughout America, there has always been fair compensation of a person's worth to that of another in the same occupation or field of endeavor. This fair distribution of pay based upon skills, knowledge, leadership and ability to overcome adversity is nowhere better illustrated than in the annual salaries of military personnel. Figure 8 provides a list of how much more the salary of a General is over enlisted personnel. The salaries shown for the Army are very much the same for the Navy.

The breakdown of how much more is the worth of an Army General versus personnel below such an august position is based solely on responsibility, knowledge, and leadership. Would you say this is a fair and equitable way in the distribution of annual salaries? It would be nice if the corporate salary structures of employees were solely based on skills, knowledge and the planning-analytical abilities of each worker and manager, not solely of the profits made. Profits made that are exceedingly higher than the salaries that each worker deserves should be dispersed to shareholders and care for those who are jobless.

Should any corporate president or millionaire earn 5 times more than a scientist, engineer, doctor, lawyer or any other professional and skilled worker? A fair answer is yes if that person is a corporate president or multimillionaire that has 5 times more knowledge, expertise, brains and experience than those who have invested years of schooling to be an indispensable asset to make the company productive and profitable.

The above figures are presented to have people visualize and understand that no millionaire is worth more than 5 times the yearly earnings of professional, skilled, medical workers and the annual salary of an Army General. Certainly, it is demeaning and ridiculous that a billionaire is worth 5,000 times greater than a professional or skilled worker. There is a definite imbalance of how our society regards the individual worth of workers at all levels. For they are the ones that make it possible for one to become a millionaire or billionaire.

For one person to make a billion dollars in one year is a travesty against fairness towards skilled and professional workers and employees of any enterprise. Could it be that billionaires will not admit to being unfair because they lack integrity, kindness, and love of mankind? It is ridiculous to believe any person's income should be more than 4 to 5,000 higher than that of a skilled or professional worker. It reflects the greed, ignorance, selfishness, and immorality of the American mind that has led to the imbalance of wealth in the U.S. economy. Yet, the ignorance of people in America to tolerate such an imbalance is more extraordinary.

Let's examine one of our most successful billionaire's net worth with that of a professional or skilled worker. According to TechtoFacts on 10/02/2019, the annual income of billionaire Bill Gates was \$4,123,560,000, which may be verified via the Internet link, <a href="https://www.techtofacts.com">https://www.techtofacts.com</a>.

When one compares the annual wage of a professional or skilled worker making \$200,000 to billionaire Bill Gates annual income we find the difference in net worth is excruciatingly phenomenal. Below, Bill Gates expertise, mental acuity, and experience is worth 20,618 times that of a professional or skilled worker.

\$200,000 \$4,123,560,000 20,618 times

Amazing if not preposterous, ridiculous, ludicrous, and absurd. It may be rightfully said that there is an injustice in how we regard the value of work of people in America. How can people in the United States get our government leaders and corporate managers to agree on wages based upon education, skills, and professional training? Should the earnings from profits made by multimillionaires be exceedingly higher then those workers that have made their success a reality? Can the excess in earned wages of all incomes by multimillionaries, professional and skilled workers be used to benefit all Americans?

Will U.S. billionaires be willing to give up the many billions of dollars that are not presently used to benefit mankind? We have seen with the two examples of George Soros and Bill Gates that their contributions

to charity are admirable, but less than 3% of their net worth. Instead, with their billions they have used their wealth to transform society into a world they can control. The reader may wish to return to the activities of George Soros and Bill Gates mentioned above to see that they have, in fact, used their wealth that goes against the betterment of mankind. Their actions reflect a mentality that is not committed to make the lives of American people productive and raise their quality of life. Unfortunately, it is not realistic to believe multibillionaires will be willing to share their wealth for the benefit of their brothers and sisters, the workers they owe their success to in America.

However, there is hope if Americans will have an open mind to visualize and investigate that the promise of artificial intelligence can be used to benefit all mankind. The next chapter pursues that vision.

# III. Mankind's Future with Artificial Intelligence

This chapter provides significant ideas for creative minds and innovative entrepreneurs to consider in making a better world for mankind. A world where all people need to understand there is a shocking imbalance in the economic system of wealth that must be resolved in the United States and many countries.

## 3.0 A Way to Achieve a Future for Mankind

The negative impact of people losing their jobs by use of Artificial Intelligence can be resolved. However, resolution requires two movements, which will ultimately benefit the quality of life of all Americans and brighten the future of mankind.

- Improvement of our educational institutions and religious organizations to instill the values of integrity.
- A new perspective of how people are fairly compensated for their work by using AI's potential to benefit the economy.

Discontented groups of people from many different races have expressed their anger caused by the loss of jobs and a poor quality of life. After a policeman put his knee and weight of his body on the neck of George Floyd for over 8 minutes causing his death it led to massive riots in many communities for several weeks. The death of a black man in such a heartless manner motivated thousands of discontented people to join the Black Lives Matter movement. The death of one black man by a white policeman initiated violence by angry mobs that burned, pillaged and destroyed churches, homes and stores in the communities of many states during June of 2020.

What the death of one black man revealed was the degradation of the character and love of country by our youth and thousands of dissatisfied people. They no longer have respect for property and human life. This anger exploded in Chicago's city of Minneapolis after George Floyd's murder culminated in widespread protests, riots and looting. The anger expressed by thousands of poor white and black citizens was not due to just the death of one black man, it has been seething for years by discontent brought about by lack of jobs, poor education, and lack of a promising future.

The anger is so extensive, in many black communities, blacks were killing blacks. After Floyd's death in Minnesota, from May 29 to June 1, 2020, the city of Chicago had 85 people shot, 24 fatally, and at least 61 were injured. Even on Father's Day that followed, this anger and violence persisted where more than 100 people were shot, 14 fatally killed, and more than 50 were injured.

In many states of America, the Black Lives Matter movement has infected the minds of people who appear to have had a poor education of the founding and history of the United States. Rather than learn from the past injustices that America went through as it matured into the best country for disadvantaged people, they rather destroy its history. They even pulled down and destroyed monuments of America's past because they believe there is no equality in the application of law and order. The ability for our youth to discuss and communicate differences so that a dialogue can arrive at solutions has been replaced with anger and blinded actions that only destroys their future and the communities they live in.

On July 23, 2020 in Milwaukee, Wisconsin, a black man, Bernell Trammell was shot dead by another black man which belies if Black Lives Matter really is taken seriously by followers of this auspicious slogan. Bernell was shot in the head for having voiced his support for President Trump and displaying signs that read, "Vote for Donald Trump 2020." He appeared on the street corners to advocate why he, a black man, believed that the reelection of President Trump would benefit all black people as was demonstrated in the years of his presidency. It is clear that the national news media, predominately supported, funded

and owned by successful billionaires has insidiously indoctrinated the black murderer with propaganda of hate news against President Trump, which led to anger, hate, violence, and finally murder.

Can we say that our educational system, at every level, and our religious institutions have failed? Is there yet another reason, which is the inequality being created by Artificial Intelligence that causes loss of jobs, lower incomes, and homeless people living on the streets of many cities? This author believes that it is both the lack of integrity and intellect taught by our educational-religious organizations and the inequality of wealth acerbated by AI implementation. It is these two areas that need to be explored and revised to resolve the AI impact.

# 3.1 Improve America's Educational and Religious Institutions.

Throughout America, we find that people have many bias towards others, racism still exists and encouraged by dishonest leadership. Our educational institutions have corrupted their mandate by not teaching our youth facts but opinionated fake news to arrive at logical decisions. They have even altered history books by stressing the negative rather than the positive aspects of American history. These youths have become the journalists and editors of major news media companies and may be reason why so much of the news is poorly researched ending up as biased fake news. Our religious organizations have failed to teach their followers to respect people from all faiths with kindness and truth. Both our educational and religious teachers have respectively failed to emphasize the qualities that build character with integrity and appear to have overlooked the greatest command given by a man of God – love one another.

We know that in spite of all the money spent on education, our schools, colleges and universities have produced graduates ill prepared to earn a living. The literacy scores of high school graduates in math and reading attest to poor performance as teachers have geared their efforts to address racial differences. Liberal and progressive teachers in their efforts to raise the consciousness of people with different color skin and

ethnicities have distorted historic facts in teaching their students and have cast a shameful light on America's past and its future.

The attributes of truth, kindness, compassion and love for one another and a sound education allows people to act with integrity to assist and support others. It is these ingredients, values that make us caring human beings. It should be the mandate for our educational systems and religious institutions to instill integrity in our youth and emphasize our inherent ability to love one another. A strong sense of values and integrity is an effective way to redirect our economy.

We are all human beings with gifts that can be developed, shared and enjoyed by one another. Are we human enough to share our successes with those who are disadvantaged by not having received a good education, born into a world with parents who were not able to instill values because they had to struggle to make a living? Such is the world where these disadvantages contribute to loss of work, which creates mental, physical, and moral deficiencies that affects succeeding generations.

Yes, our nature must be groomed to have us perceive ourselves and our world with high standards of integrity both morally and intellectually. With this elevated perception, all of us will be willing to share our success with others, even our wealth that we may have in abundance. The perception of integrity is based on love for one another and is key to a transformation that enables all of us to make a better world.

### 3.2 A way to Resolve the Inequality of Net Worth in America

This author does not advocate a social reform to replace Capitalism in America. Of all the countries on earth, America is the greatest country that provides an opportunity for all people, regardless of color or religious beliefs to make their own choices and achieve their goals in life. What is lacking is a deterioration in our schools, at every level, to teach facts that allow us to learn from history, not change or misconstrue facts to achieve a political agenda.

The reality of riots in America is due, in part, to our entire educational system up through the university level where teachers and professors have tainted their students with political views that cast a demeaning perspective on the honor and integrity of America's history, values, love of country and all people. But this area that forms the development of character and integrity of human beings is just one aspect of making a better future for all Americans.

We know millions of people harbor discontent and anger that exists because their quality of life is much lower than those who have been afforded an education and achieved a comfortable life. However, much of the anger, disillusion, dissatisfaction, and discontent of millions of Americans has been created by the displacement of workers by AI and it will worsen in the future.

The 2017 Oxfam report indicated that just 8 billionaires own half the wealth in the world. Here in America, we have the most billionaires who can help counter the loss of jobs due to increasing AI automation. A 2019 Brookings article cited above indicated that in 2018, U.S. households held over \$113 trillion in assets. With this accumulation of wealth in the United States for 2019, it may present a logical solution to actively assist in solving the increase in job loss that leads to suicides, disillusionment, and poverty that affects any chance for a better life for millions of people.

The following solution proposed is a suggested way for multibillionaires to have everybody in America enjoy a quality of life that allows them to attain any education or professional skills and be successful. It is an approach that can be better thought out by those with experience in the financial and economic arena willing to work with the great analytical minds who use artificial intelligence to make it happen seamlessly.

### 3.3 Simplistic Income Calculation for Workers

The monetary figures given below allows people to obtain a perspective of our monetary system of wealth. It does not revise the Capitalistic system in America nor promotes a Socialistic system but a renewed view of how people with kindness, integrity and love can make America better for all of us. Let us begin by looking at what a trillion dollars looks like. Few of us have an appreciation of the enormity of a trillion dollars in billions of dollars. To understand what a trillion, billion, and millions look like in terms of dollars they are listed below:

One trillion = \$1,000,000,000,000 dollars = 1,000 billion dollars

One billion = \$1,000,000,000 dollars = 1,000 million dollars.

One million = \$1,000,000 dollars = 100,000 dollars 10 times.

Indicated above, the 2019 Brookings article indicated that in 2018, U.S. households held over \$113 trillion in assets. For context, that is over five times as much as all the goods and services produced in the U.S. economy in a single year. If that amount were divided evenly across the U.S. population of 329 million, it would result in over \$343,000 for each person. For a family of three, that's over a million dollars in assets.

This is a senseless calculation because it does not take into consideration the differences in wages between billionaires, millionaires, middleincome and low-income workers. Let us look at \$113 trillion dollars in another way that preserves the capitalistic principle of individual freedom and opportunity, the ability to become a millionaire.

Forbes indicated that in 2019 there are 607 American billionaires. In 2019 the U.S. population was estimated at 329.45 million. To preserve the capitalistic dream of becoming a billionaire, let us insure each of the 607 billionaires acquire a yearly wage of one billion dollars. This amount is deducted from the total of \$113 trillion dollars net worth in U.S. namely,

\$113,000,000,000,000 (dollars) - \$607,000,000,000 (dollars) = \$112,393,000,000,000 dollars

By subtracting the 607 billionaires from a population of 329.45 million, the people who are not millionaires = 329,449,393.

Dividing \$112,393,000,000,000 by 329,449,393, we get:

\$341,154 dollars for each person, which is not very different from the \$343,000 calculated by Brookings above.

By golly!! Over \$341,000 dollars for each person is ridiculous when in today's economy the average wage is only from \$50,000 to \$75,000 and professional-skilled workers earn around \$200,000 annualy. Let us consider an alternate calculation where poverty, joblessness, and homeless people are eliminated and average workers, as well as professional-skilled workers and present-day billionaires benefit from the wealth in this country.

### 3.4 Calculation of Worker Incomes Using U.S. Net Worth

The simplistic calculation failed to take into account the annual incomes of average workers and skilled-professionals. It is fair that investing years of education and developing skills, the following skilled-professionals can make anywhere from \$100,000 to one million dollars per year: scientists, engineers, doctors, nurses, lawyers, computer experts, mechanics, program managers, professors, teachers, professional athletes, actors, entertainers, police and military personal, state and federal employees. To simplify the calculation, assume they earn or receive (earn) an average wage of \$300,000 dollars a year.

NOTE: Receive or earn does not matter because we are trying to find out if the U.S. net worth of \$113 trillion can sustain all workers.

Using the same approach for the simple calculation, where 607 billionaires receive a yearly income of one billion dollars from \$113 trillion and the total U.S. population of 329,450,000 million is also reduced by that amount we get: This amount is deducted from the total of \$113 trillion dollars household assets in U.S. namely,

\$112,393,000,000,000 and a population of 329,449,393.

Now, let us see if the U.S. net worth of \$112,393,000,000,000, which already has deducted the 607 billion made by 607 billionaires annually, can satisfy the population of 329,449,393. To reflect realistic annual wages, we will project that 25 % skilled-professional workers receive/ earn an average of \$300,000 dollars and, 75% of the remaining population (average workers) receive /earn a yearly income of \$100,000 dollars.

From the net worth of \$112,393,000,000,000 subtract,

75% of average workers + 25% of professional-skilled workers 0.75(329,449,393)\$100,000 + 0.25(329,449,393)\$300,00024,708,704,475,000 + 24,708,704,475,000 =

\$49,417,408,950,000 dollars received by workers

Subtracting \$49,417,408,950,000 from \$112,393,000,000,000 =

U.S. net worth remaining: \$62. 97 trillion dollars

Only 43 % of the total net worth of \$113 trillion was spent on wages for billionaires, skilled-professional and average workers for the entire United States.

The above analyses show that the entire population of America can enjoy a quality of life by disbursing \$49.4 trillion of the U.S. net worth of 113 trillion, which is less than half at 43%. To recap, the following wage parameters were met:

- 607 American billionaires receive a yearly income of \$1 billion.
- 75% U.S. population of 329,447,906, each receive \$100,000 per year, with or without a job.
- 25% remaining population of skilled and professional workers receive \$300,000 dollars, with or without a job.
- \$62.97 trillion left can be used to fund education, rebuild schools, cities, infrastructure, and the military.

This proposed solution can easily be developed and implemented using artificial intelligence. We know that an AI system can be designed with the interconnection of databases for each state in the United States of America, which includes Hawaii. AI can be developed for the entire U.S. economy with an automated system that facilitates the distribution of wealth fairly and provide a quality of life for all Americans. This proposed solution would also work for all other country economies.

### 3.5 Benefits Using the U.S. Capitalist AI Fund

All American workers can enjoy the benefits of the proposed AI solution, which we may designate the *U.S. Capitalist AI Fund*. An automated AI system, it is an interconnected database system that monitors earned salaries and funds workers of all businesses, companies, and corporations. Let us examine these benefits.

- Present 607 corporation billionaires receive a yearly income
  of \$1 billion tax free. All other billions earned go into the U.S.
  Capitalist AI Fund. This is the pinical of a capitalist system to
  reward workers that become billionaires. It is their success that
  is used to benefit mankind.
- 2. 75% U.S. population of 329,447,906 receive \$100,000 dollars per year tax free, with or without a job. Earnings above \$500,000 go into the U.S. Capitalist AI Fund. This allows a worker to put \$400,000 into a savings account to preserve the incentive to someday become a millionaire.
- 3. 25% remaining population of skilled and professional workers receive \$300,000 dollars per year tax free, with or without a job. Earnings above \$1,000,000 go into the U.S. Capitalist AI Fund. This allows a skilled-professional worker to put \$700,000 into a savings account to preserve the incentive to someday become a billionaire.

- 4. \$62.9 trillion left can be used to rebuild our cities, schools, infrastructure, free healthcare, free education to the university level, U.S. military defense, and use of all media that will improve the morality and integrity of Americans.
- 5. All expenses for homes, apartments, food, and entertainment are paid by the people in Benefits 1-3.
- 6. The IRS tax system is eliminated because the U.S. Capitalist AI Fund will have funds for the military, health care for all citizens, and pay down the national debt.
- 7. All welfare and worker retirement programs for retired and disabled people are eliminated because the U.S. Capitalist AI Fund provides the same outlay of annual incomes after a recommended age of 12 years of age. This is logical since the parents receive an annual wage to support their clildren.

# 3.6 U.S. Capitalist AI Fund Resolves Inequality Using GDP

The 2018 U.S. households net worth of over \$113 trillion in assets as a solution may be compared to using the annual exchange of goods and services in America. The GDP (Gross Domestic Product) of 2019 in America was \$21.2 trillion. Knowing that the net worth solution in Section 3.4 required \$49.4 trillion, the annual wages/income for both professional-skilled and average workers had to be reduced.

Using a population of 329,449,393, the yearly income received by billionaires stayed the same but the income of average and skilled-professional workers had to be adjusted respectively to \$35,500 and \$150,000 per year tax free.

From the 2019 GDP of \$21,200,000,000,000 subtract,

75% of average workers + 25% of professional-skilled workers 0.75(329,449,393)\$35,500 + 0.25(329,449,393)\$150,000

8,771,590,088,625 + 12,354,352,237,500

Subtract the \$21,125,942,326,125 U.S. Capitalist Fund outlay

\$21,200,000,000,000 - \$21,125,942,326,125 =

U.S. GDP remaining: \$74.0 billion dollars

The benefits of using a GDP of \$21,2 trillion are not as exciting as the \$113 trillion U.S. net worth calculation. The following two benefits were reduced significantly.

75% U.S. population of 329,447,906 receive \$35,500 instead \$100,000 dollars per year tax free, with or without a job. Earnings above \$500,000 go into the U.S. Capitalist AI Fund.

25% remaining population of skilled and professional workers receive \$150,000 instead of \$300,000 dollars per year tax free, with or without a job.

The results between using a U.S. net worth of \$113 trillion and a U.S. GDP of \$21 trillion were shown to compare the incomes of skilledprofessional and average workers. The outcomes were respectively adjusted from \$300,000 to \$150,000 and \$100,000 to \$35,000 dollars annually. These two approaches were performed to verify that the conception of an operable U.S. Capitalist AI Fund is realistic and doable.

#### 3.7 **Artificial Intelligence Requires Constitutional Changes**

The differences in the proposed net worth and GDP incomes are appreciable and to try to reach for the highest attainable quality of life for all Americans will require a unified effort by our most successful business leaders and trusted political leaders. The change to create a psychological and moral point of view that implements a correction of the imbalance of net worth in America is a worthy challenge. It will require some new laws to the Constitution of America because for an interconnected AI system to work on a scale that envolves all 50 states there must be consensus by all to make it happen seamlessly and effectively.

It will require our greatest minds, those with perception, compassion and a love for others to assist and work with our successful billionaires and multimillionaires to share their wealth and become true humanitarians. Yes, it will require our great leaders in the Congressional, Senate, Executive and Judicial seats of honor to work with AI experts to conceive and write those laws into our Constitution. Laws that will provide the guidance to transform America into a fair nation that provides an equal opportunity for all its people to live a quality of life never before achieved on earth.

The above Constitutional approach requires the American people to get our government leaders and corporate managers to agree on wages based upon education, skills, and professional training whereby profits and earned income can be used to benefit all Americans.

Today, there are many analytical and logical minds that utilize the tools of Artificial Intelligence. They can design automated programs that can facilitate the distribution of profits and earned incomes for workers of the many businesses, companies, and corporations to have workers receive income commensurate with their skills and even maintain a quality of life for nonworkers. As with the U.S. Capitalist AI Fund described above, this may be an area where multimillionaires and billionaires can help finance such a challenging effort. If they are unwilling to do so, it remains for every citizen of the U.S. to sign a petition for our government leaders to address how to have multimillionaires and billionaires contribute to the well-being of all workers in America using artificial intelligence.

As an author, it is an opportunity to write about the AI impact and present what could be effective ways to have others with capable abilities and vision to pursue the course to correct the imbalance of income for American workers. May the ideas presented in this book serve as a catalyst to stimulate our most bright and gifted minds to accomplish a task that has never been greater than improving the lives of American citizens. once instituted, will someday provide an AI system that can serve as a model for other countries to effectively implement and provide a better livelihood for their people.

### 3.8 AI Can Correct the Imbalance of Incomes and Renew the Future

The above results of the net worth solution verifies that the U.S. Capitalist AI system is not an idealistic dream. Figures don't lie. The question is, how can it happen when according to the 2017 Oxfam report, just 8 billionaires own half the wealth in the world?

With honest reflection, how much more is a millionaire worth over a skilled or professional worker in the U.S.?

It seems unfair to think that a millionaire should earn 5 or 10 times more than a scientist, engineer, doctor, lawyer, or any other professional and skilled worker. That is saying a corporate president or multimillionaire has 5 to 10 times more knowledge, expertise, brains and experience than those who have invested years of schooling to be an indispensable asset to make a company productive and profitable. Let's return to Section 2.4, Figure 8, which compares a \$200,000 annual salary of professionalskilled workers, which is also the annual salary of an Army General, to that of a millionaire and billionaire. It is repeated below.

The above figures are presented to have people visualize and understand that no millionaire in any business is worth more than 5 times that of professional and skilled workers. Certainly, it is demeaning and ridiculous that a billionaire is worth 5,000 times greater than the skills and experience of a professional-skilled worker and an Army General. There is a definite imbalance of how our society regards the individual worth of workers at all levels. For they are the ones that make it possible for one to become a millionaire or billionaire.

For one person to make a billion dollars in one year is a travesty against fairness towards skilled and professional workers and employees of any enterprise. Could it be that billionaires will not admit to being unfair because they lack integrity, kindness, and love of mankind? It is ridiculous to believe any person's income should be more than 5 to 5,000 higher than that of a skilled or professional worker. It reflects the greed, ignorance, selfishness, and immorality of the American mind that has led to the imbalance of wealth in the U.S. economy.

It is also unfair to ridicule or deprecate a multimillionaire or billionaire for common sense knows that they definitely are not 5 to 5,000 smarter than their most skilled planners, analysts and innovators of new and enhanced products. Much of their wealth is derived from the millions of profits from products sold and has nothing to do with brains. But those profits should not be going to one individual and ignore the workers that have made such success happen. Rather, the excess in wealth should go back into the economy or a fund that trys to provide a balance of wealth for all Americans. That is the goal of the U.S. Capitalist AI Fund.

Will U.S. billionaires and multibillionaires be willing to give up the many billions and millions of dollars that are not presently used to benefit mankind? We have seen with the two examples of George Soros and Bill Gates that their contributions to charity are admirable, but less than 3% of their net worth. Instead, with their billions they have used their wealth to transform society into a world they can control. The reader may wish to return to the activities of George Soros and Bill Gates mentioned above. Their actions reflect a mentality that is not committed to make the lives of American people productive and raise their quality of life. ### Final Thoughts for Americans as We Enter a New Era 3.9

This article presents a way to resolve the artificial intelligence impact. It is not the only way, but lends itself to open the hearts and minds of Americans to investigate, study, and devise ways to improve the quality of life for all Americans. It was written to give the American people a perspective and hope of how AI can be an effective tool in elevating the lives of Americans by:

- Renewal of our educational and religious organizations to emphasize responsibility for the well-being of others and integrity that is buttressed with the values of truth, kindness, and love for one another.
- Balance the earning capacity of all workers in America to eliminate poverty, countless homeless people, and attain an education to contribute to the U.S. economy by the effective use of AI.
- Provide the ability for everyone to attain an education and acquire a sense of self-worth, integrity and an opportunity to achieve higher goals in life.

Great minds have thought of the simple solution to counter unemployment by paying a basic income to everyone regardless of their education and training to ensure a minimum standard of living. They would be free to pursue additional income in the marketplace, and capitalism would proceed as usual. This simplistic solution has been proposed by Thomas Paine, Bertrand Russell, Martin Luther King Jr., James Tobin, Paul Samuelson, John Kenneth Galbraith, Milton Friedman, Friedrich Hayek, and Richard Nixon. However, they have not considered a fair income for professional and skilled workers that can easily make a million dollars a year nor did they perceive how people living in poverty can also have an opportunity to develop their talents and achieve a better quality of life. Nor did they give some recognition to the billionaires and multimillionaires that do exist and are instrumental in providing for new and productive enterprises in our capitalistic system.

The net worth income solution proposed provides for all people the opportunity to compete and innovate in the market economy. In addition, they will very likely get or further their education and want to raise their incomes to enter a challenging field or start a small business. The proposal that 75% of the population gets a basic income of \$100,000 and can earn up to \$500,000 and 25% of professional and skilled workers can receive \$300,000 and earn up to a million dollars can be achieved. But, as stated in Section 3.7, Constitutional laws will need to be introduced and will require compassionate U.S. billionaires and multimillionaires that are and willing to work with innovative AI experts to make it happen.

Even if some people making a basic income of \$100,000 dollars choose not to work, they might be able to contribute to society in other ways, such as writing articles; creating free games and applications on the internet; and singing, dancing and playing an instrument on the street. Their own enjoyment of creativity can be enjoyed by others. The significant thing is that all people are able to choose what they would like to contribute to their community, albeit, the world.

A word of caution. There are many forces in the U.S. that have gained control of the destiny of Americans. We have reviewed some of the unfruitful activities of two billionaires, but they are a small part of elites and a wealthy group that control incognito the lives of American citizens. Unknown to the average citizen, another incognito operation has been going on for over 70 years. 

## The Beginning of the Universe Began with the Electron

After presenting the possibility that consciousness pervades the universe, it became natural for me to expound on a profound belief that Everything Has a Beginning - Even the Universe. David Tong, a professor of theoretical physics at Cambridge University gave a presentation titled, Quantum Fields: The Real Building Blocks of the Universe.<sup>4</sup> He indicated that the fundamental building blocks of matter are not discrete particles but continuous fluid-like substances, spread throughout all of space, which are called fields. The most familiar examples of fields are the electric and magnetic field. Electromagnetic fields exists everywhere as a fluid that fills the entire universe. It is the author's belief that there is a transformation of energy within these fields that forms the electron, a negatively charged particle.

As the electron came to exist in infinite numbers, it inherently possessed a consciousness to evolve atoms, which formed the elements of our universe. The atom consists of protons and neutrons that are, like the electron, similarly created from fields but the proton has a positive charge and neutrons a neutral charge. A review of the Periodic Table of Atomic Numbers verifies that the electron may be the mastermind in the creation of atoms. According to the Keepers, this isn't the first-time humans have gotten to this critical point (in our history) and have self-destructed, but there is a good chance we can evolve this time and avoid self-destruction. Sparks outlines the exact steps advised by the Keepers of how humanity can save the Earth, save itself as a species, and join the galactic neighborhood.

CIA and FBI played mind games with him by moving objects around in his home and car. He said that the discovery of alien life could be the most important event in history.
- 2 Eugene Mallove: An American scientist, eminent physicist, founder of the New Energy Foundation, and expert in cold fusion who apparently had working tabletop devices was beaten to death in 2004 at the height of his career and the day before a public announcement of his findings.

- Richard Church: Chairman of CIGIUFO also died the next 52 day after Frank Edwards on June 24, 1967.
- Willie Ley: UFO ET space writer, well-known writer on 53 rockets and astronautics, Ley wasn't directly involved in UFOlogy but he wrote about space travel. Flying saucers are space travelers. He also died the next day after Frank Edwards on June 24, 1967.
- Rep. Rouse: Had been supporting Edwards in his campaign for 54 Congressional attention to the UFO issue, died of a similar heart attack.
- Frank Scully: An author, died of a heart attack the next day 55 after Frank Edwards on June 24,1967. Scully wrote the first significant book about UFOs - Behind the Flying Saucers - in which he mentioned the "little men" or alien humanoids, electro-magnetic powerplants of saucer, EM effects, and the Air Force's campaign to hide the truth about UFOs from the public, all "ridiculous" ideas that were later accepted.
- James Forrestal: Former Secretary of Defense committed 56 suicide by purportedly jumping out a hotel window.
- M.K. Jessup: Deeply immersed in the relatively new UFO-57 phenomena problem died of a suicide.
- Dr. James McDonald: Senior physicist, Institute of Atmos-58 pheric Physics and also professor in the Department of Meteorology at the University of Arizona. In the 60s he tried to convince Congress to hold serious, substantial subcommittee meetings to explore the UFO reality. He died in 1971. He purportedly shot himself in the head. But it only was a gunshot wound to the head. He was wheelchair-ridden but somehow, several months later he drove to the desert and died of a fatal shot.

- 110 Mae Brussell: Acutely interested in UFOlogy. Many years of her research is available at The World Watchers Archive. A gutsy, no-holds-barred, investigative radio host died of a fastacting cancer just like Ann Livingston and Karla Turner.
- Truman Bethurum: He claimed to have ridden to other worlds in flying saucers. He was a quiet man who seemed incapable of making up the fantastic adventures he had. He wrote two books about them before dying quietly in bed on May 21, 1969.
- 112 Dr. George Hunt Williamson: Williamson disappeared while on an anthropological expedition to Peru in 1965. He was noted for his explorations of ancient Indian sites in the Andes, which he suspected were saucer bases, landing fields, and cave headquarters. He believed the saucermen were still there. Later, he experimented with shortwave radio contact, claiming in 1952, that he had established communications with UFOs. Saucers were observed hovering over his radio shack during these broadcasts. Williamson wrote several books about UFOs, the most noteworthy was The Road in the Sky.
